5 RESOLUTION ADOPTING THE BIG VALLEY GROUNDWATER MANAGEMENT PLAN

6 WHEREAS, this Board adopted a Resolution of Intent to prepare a
7 Groundwater Management Plan for the Big Valley Groundwater Basin on
8 June 9, 1998; and

9 WHEREAS, the Board appointed the Big Valley Groundwater
10 Management Zone Commission to assist in writing and reviewing the
11 Plan and during the course of its development, public meetings were
12 held to obtain input from the community; and

13 WHEREAS, the Big Valley Groundwater Zone Commission worked with
14 staff to finalize the Plan and such Commission approved the Plan at
15 its February 5, 1999 meeting; and

16 WHEREAS, the Plan, authorized by the Groundwater Management Act
17 (Water Code Section 10750 et seq.), is designed to monitor, analyze
18 and implement effective management practices in the utilization of
19 protection of valuable groundwater resources in the Plan area; and

20 WHEREAS, the Board held a public hearing on May 18, 1999 for the
21 adoption of said Plan; and

22 WHEREAS, the Board desires to formally adopt said Plan.

23 NOW, THEREFORE, BASED UPON THE FOREGOING RECITALS, THIS BOARD
24 DOES HEREBY find and determine as follows:

25 1. That the Big Valley Groundwater Management Plan is hereby
26 adopted to be effective as of May 18, 1999.

27 2. That the adoption of said Plan is statutorily exempt from
28 the California Environmental Quality Act (CEQA) pursuant to Section
15262 of the CEQA Guidelines.

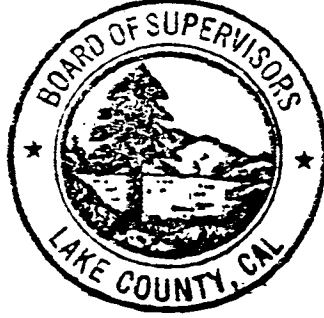
